

In response to COVID-19, HHSC has been posting MCO Notices to TexConnect with guidance that contains dates for which the guidance applies. Many dates on posted guidance are set to expire on June 30, 2021.

One update has been made to the COVID-19 MCO Notices Extension table that was published to TexConnect on June 25, 2021.

Key Details:

HHSC updated many MCO Notices with guidance dates that expire June 30, 2021 to extend through July 31, 2021. The previously posted individual notices in TexConnect were updated to reflect the new extension dates.

The following flexibility is NOT set to end and is extending through July 31, 2021:

- Suspend in-person orientations, allowing for telephonic orientation for consumer directed services.

The attached COVID-19 MCO Notices Extension table has been updated to reflect this change.

Below is an updated full list of flexibilities now set to end:

Ending July 31, 2021:

- Waive the signature requirement for prescription drug deliveries in Medicaid and CHIP.
- Use of Texas Medicaid Public Health Emergency (PHE) provider enrollment application, a short-form application with reduced screening requirements, is allowed in place of the standard provider enrollment application, to include: requirements that out-of-state providers be licensed in the state where they are providing services when they are licensed in another state; allow licensed providers to render services outside of their state of enrollment; and waiving application fee, site visit, and finger-print-based criminal background checks.

Ending by August 31, 2021:

- Suspend managed care and fee-for-service service coordination requirements for face-to-face visits, offering telehealth or telephonic service coordination instead, when appropriate.
